1. Southeastern Baptist College (SBC), Federal School Code 015024, acknowledges that we have signed and returned the Certification and Agreement form. SBC will use no less than 50% of the funds as emergency grants to students.
2. The total amount of funds SBC has received from the Department of Education for emergency grants for students total \$237,499.00.
3. The total amount of CARES Act emergency grant funds distributed is \$237,499.00.
4. The estimated total number of students eligible for Title IV assistance and thus eligible for emergency grants for students is 110.
